RESOLUTION RATIFYING AND AUTHORIZING EXECUTION OF A SIDEBAR AGREEMENT BETWEEN THE BOROUGH OF MENDHAM AND MENDHAM BOROUGH PBA LOCAL 384 ADDING DANIEL CAMPIONE'S LENGTH OF SERVICE TO SECTION 14 OF THE CONTRACT

WHEREAS, the Borough of Mendham ("Borough") and Mendham Borough PBA Local 384 ("PBA") are parties to a collective negotiations agreement for the period of January 1, 2020 through December 31, 2026; and

WHEREAS, Section 14 of the collective negotiations agreement sets forth the length of service for purposes of computing vacation time; and

WHEREAS, the Borough hired new police officer Daniel Campione on March 12, 2025, whose length of service is not included in Section 14; and

WHEREAS, Section 14 of the collective negotiation needs to be updated with the length of service of September, 2018 for Daniel Campione; and

WHEREAS, the Sidebar Agreement attached hereto incorporates these changes.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Mendham, County of Morris, State of New Jersey, as follows:

1. A Sidebar Agreement, attached hereto and incorporated herein, updating the length of service for Daniel Campione is hereby ratified.
2. The Mayor and Clerk are hereby authorized and directed to execute the Sidebar Agreement.
3. The Sidebar Agreement and this Resolution shall be kept on file in the Office of the Borough Clerk for inspection by the public.

 - a. Daniel Campione September 2018


