**RESOLUTION AWARDING A CONTRACT TO DLS CONTRACTING, INC. FOR
THE PHOENIX & KNOLLWOOD DRIVES ROAD IMPROVEMENTS PROJECT
NJDOT MUNICIPAL AID PROGRAM LA-2023**

WHEREAS, the Borough of Mendham was awarded an NJDOT Municipal Aid Program LA-2023 Grant of \$199,815 for the Phoenix and Knollwood Drives Road Improvements \$199,815, and \$90,000 allocated in the 2023 CIP and

WHEREAS, the Borough of Mendham solicited bids for the Phoenix & Knollwood Drives Road Improvements project; and

WHEREAS, six sealed bids were received and opened on May 29, 2024, in accordance with the advertised date for acceptance of bids; and

WHEREAS, the lowest apparent bid was from DLS Contracting, Inc. in the amount of \$392,295.30 for the Base Bid and \$6,880.00 for Alternate Bid No. 1; and

WHEREAS, Boswell Engineering has reviewed the bid from DLS Contracting, Inc., found that it complies with the required technical specifications, and per correspondence dated May 30, 2024, recommended awarding both the Base and Alternate Bid No. 1, subject to CFO certification and review by the Borough Attorney; and

WHEREAS, the Borough Attorney has reviewed the bid from DLS Contracting, Inc. and determined that it is substantially in proper form and in compliance with the provisions of the Local Public Contracts Law, N.J.S.A. 4A:11-1 et seq., rendering DLS Contracting, Inc. the lowest responsive, responsible bidder; and

WHEREAS, the Borough's Chief Financial Officer has certified that sufficient funds are available for this contract.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Mendham, County of Morris, State of New Jersey, as follows:

1. The Borough Council hereby awards a contract to DLS Contracting, Inc. for the Phoenix & Knollwood Drivers Road Improvement project in an amount not to exceed \$392,295.30 for the Base Bid and \$6,880.00 for Alternate Bid No. 1, in accordance with its bid.
2. The Mayor and Borough Clerk are hereby authorized and directed to execute said contract.
