RESOLUTION TEMPORARILY EXTENDING CONTRACT WITH PEGGNET COMPUTERS FOR IT SERVICES THROUGH MAY 31, 2021 PENDING ISSUANCE OF A COMPETITIVE CONTRACTING RFP

WHEREAS, in accordance with the Local Public Contracts Law, <u>N.J.S.A.</u> 40A:11-1 <u>et seq.</u>, and pursuant to Resolution 196-2018 adopted on December 20, 2018, the Borough of Mendham awarded a contract to PeggNet Computers ("PeggNet") for IT Services ending on December 31, 2020; and

WHEREAS, the Borough timely solicited bids for IT Services for 2021 and 2022 and received four bids opened on November 5, 2020; and

WHEREAS, due to a wide discrepancy in bid amounts, the Borough determined that the specifications should be revised and clarified to promote the vital purpose of competitive bidding and accordingly, rejected all bids pursuant to N.J.S.A. 40A:11-13.2 and Resolution #186-2020 adopted on December 17, 2020, which resolution also authorized the use of the competitive contracting process set forth in N.J.S.A. 40A:11-4.1 et seq.; and

WHEREAS, due to unforeseen delays, including those imposed by the COVID-19 pandemic and ongoing State of Emergency, the Borough has had to extend the contract with PeggNet pending the finalization and issuance of a competitive contracting RFP; and

WHEREAS, the competitive contracting RFP has been submitted for publication on April 29, 2021 with contract award expected to take place in May 2021; and

WHEREAS, the Borough wished to extend the PeggNet contract through May 31, 2021 to ensure critical continuity in IT services to the Borough; and

WHEREAS, PeggNet, per correspondence dated March 25, 2021 has agreed to the proposed contract extension at the current monthly contract amount; and

WHEREAS, the Borough's Chief Financial Officer has certified that sufficient funds are available for these contract extensions.

THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Mendham, County of Morris, State of New Jersey, as follows:

- 1. The Borough hereby extends the contract with PeggNet Computers for IT Services at the current monthly contract price not to exceed \$3,668.00, for the period through May 31, 2021.
- 2. The Mayor and Borough Clerk are hereby authorized and directed to execute said contracts.
- 3. This Resolution and contracts shall be available for public inspection in the office of the Borough Clerk.

- 4. This resolution shall be submitted as part of the 2021 grant application package submittal to the New Jersey Historic Trust.
- 5. The Mayor, the Borough Clerk, together with all other appropriate officers, employees, professionals and staff of the Borough are hereby authorized and directed to take all steps necessary to effectuate the purpose of this resolution.
