RESOLUTION AUTHORIZING THE AWARD OF A PROFESSIONAL SERVICES CONTRACT WITHOUT COMPETITIVE BIDDING TO FERRIERO ENGINEERING, INC. FOR THE DEAN ROAD IMPROVEMENTS SECTION 1 & 2 PROJECT

WHEREAS, the Borough of Mendham has a need for professional engineering services related to the Dean Road Improvements Section 1 & 2 project ("Project"), which includes pavement repair, ADA curb ramps reconstruction, drainage inlet upgrades, minor curb and sidewalk repair, roadway milling and resurfacing, traffic striping, and other incidental work, to Dean Road, from Mountain Avenue to the Main Street intersection; and

WHEREAS, the Borough has received NJDOT Local Aid Grants in the amount of \$325,000.00 for Section 1 of the Project, and \$231,700 for Section 2 of the Project; and

WHEREAS, the Borough wishes to authorize Ferriero Engineering, LLC to perform these engineering services in conjunction with the Project in accordance with its proposal dated December 18, 2020, in the amount of \$115,000.00, attached hereto; and

WHEREAS, the Borough's Chief Financial Officer has certified that sufficient funds are available for this purpose; and

WHEREAS, the Local Public Contracts Law, <u>N.J.S.A</u>. 40A:11-1 <u>et seq.</u>, requires that the resolution authorizing the award of a contract for professional services without competitive bidding, and the contract itself, be available for public inspection.

THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Mendham, in the County of Morris and State of New Jersey, as follows:

- 1. The Borough hereby awards and authorizes the Mayor and Borough Clerk to execute an agreement with Ferriero Engineering, Inc. to provide professional engineering services in connection with the Dean Road Improvements Section 1 & 2 project, at a cost not to exceed \$115,000.00, in accordance with its proposal dated December 18, 2020, attached hereto.
- 2. The contract is awarded without competitive bidding as a professional services contract in accordance with the provisions of the Local Public Contracts Law because said services are performed by a person licensed under law to practice a recognized profession.
- 3. The total fee authorized for this contract shall not exceed \$115,000.00 without the prior written approval of the Borough Council.
- 4. Notice of this action shall be published once in the Borough's official newspaper as required by law.
- 5. A copy of this resolution shall be provided to the Borough's Chief Financial Officer and to Ferriero Engineering, Inc., 180 Main Street, P.O. Box 571, Chester, NJ 07930, for their information and guidance.
- 6. This Resolution shall take effect immediately.

RESOLUTION AWARDING A FIVE-YEAR CONTRACT FOR CURBSIDE COLLECTION AND DISPOSAL OF RECYCABLE MATERIAL AND BULK WASTE (TYPE 13) TO BLUE DIAMOND DISPOSAL, INC.

WHEREAS, the Borough of Mendham solicited bids for the collection and disposal of Recyclable Material and Bulk Waste (Type 13) beginning February 1, 2021, with one-, three-, and five-year contract options; and

WHEREAS, one (1) sealed bid was received and opened on December 28, 2020, in accordance with the advertised date for acceptance of bids; and

WHEREAS, the bid received was from Blue Diamond Disposal, Inc. ("Blue Diamond"), which bid only on five-year contracts for Option #3C – collection and disposal of of Recycling Material from Public Works, 37 Ironia Road, Option #3A/Bulk – weekly curbside collection and disposal of Bulk Waste only, and Option #3A/Combined – weekly curbside collection of combined Bulk Waste and Recycling Material; and

WHEREAS, the Administration has reviewed the bid from Blue Diamond and found that it complies with the required technical specifications; and

WHEREAS, the Borough Attorney has reviewed the bid from Blue Diamond and found it in substantially proper form and in compliance with the provisions of the Local Public Contracts Law, N.J.S.A. 4A:11-1 et seq., rendering Blue Diamond the lowest responsive, responsible bidder; and

WHEREAS, the Public Works Committee has reviewed the bid options and recommends that the Borough award a five-year contract to Blue Diamond for Option #3A/Combined - weekly curbside collection of combined Bulk Waste and single-stream Recycling Material, at a total cost not to exceed \$1,386,900, with residents continuing to provide their own recycling container, per Blue Diamond's bid; and

WHEREAS, upon review of the bid, the Public Works Committee has determined that it would be cost prohibitive and inefficient for the Borough to also provide for recycling collection and disposal at the Public Works site; and

WHEREAS, the Borough's Chief Financial Officer has certified that sufficient funds are available for this contract.

THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Mendham, County of Morris, State of New Jersey, as follows:

- The Borough hereby awards a five-year contract to Blue Diamond Disposal, Inc. for the curbside collection and disposal of single-stream Recycling Material and Bulk Waste (Type 13) in an amount not to exceed \$1,386,900, for the period February 1, 2021 through January 31, 2026, in accordance with Blue Diamond's bid.
- 2. The Mayor and Borough Clerk are hereby authorized and directed to execute said contract.
- 3. This Resolution and contract shall be available for public inspection in the office of the Borough Clerk.
- 4. This Resolution shall take effect immediately.
